## Edisun Power Group: ad hoc Press Release

### **Edisun Power Group increases output and performance of its solar electricity plants – Rainer Isenrich to become CEO in 2012**

- **Rainer Isenrich, new CEO of the Edisun Power Group from Q2 2012**
- **Performance of the existing plants 9% above forecast**
- **Total output of the group reaches 14 MWp including the three new plants in France and after completion of the plant in Mallorca currently under construction**

Edisun Power Europe Ltd., a company specialising in solar power with its head office in Zurich and solar power plants located throughout Europe, has appointed Rainer Isenrich as new CEO of the group. Following the previously announced retirement of Mirjana Blume, Mr Isenrich will take over the management of the group by the second quarter of 2012 at the latest. Until then, Markus Kohler, a member of the Edisun Power Group management board, will assume responsibility for the operational management of the group. Rainer Isenrich boasts extensive managerial experience at international level which he has acquired in numerous executive positions in the field of industry. He has, for instance, held a number of management positions in the Georg Fischer Group. In addition, his role as CEO of Multi-Contact AG enabled him to gain valuable insight into the solar energy sector. According to Heinrich Bruhin, the Chairman of the Supervisory Board, "We are fortunate to be able to welcome such an acknowledged specialist to our group as Rainer Isenrich, who can call on solid international experience in the field of industry and more particularly in the solar energy sector."

By the end of October of the current year, the Edisun Power Group had generated a total of 10.4 million kWh of solar electricity. This represents an increase of 51% over the same period in the previous year. The efficient operational management of the plants and the unusually favourable weather conditions have enabled the group to generate 9% more solar electricity than forecast.

Before the end of the year, three plants with a total output of 2.1 MWp will be connected to the grid on schedule in France. Two of the plants are located on the mainland while the third is situated in Corsica.

The construction of a 2.2-MWp free-standing solar plant has begun on schedule in Mallorca. This project is being implemented in collaboration with the company Energés, with which the Edisun Power Group has fostered a long-standing partnership. Once the plant is operational, the solar electricity produced there will be fed into the island's network and paid for in accordance with the Spanish feed-in tariff system.

With the completion of the project in Mallorca, the total output of Edisun Power Europe Ltd. will be 14 MWp.

#### **Edisun Power Group**

As a listed European solar power producer, the Edisun Power Group develops, finances and operates solar power plants in various European countries. The Edisun Power Group has been active in the Swiss solar power industry since 1997 and is today among the most successful companies in the sector. It has been listed on the main segment of the SIX Swiss Exchange since September 2008. Edisun Power has achieved continuous growth in recent years and today enjoys considerable experience in both national and international projects. As of end October 2011, the company operates 70 solar power plants with total capacity of 11 MWp in Switzerland, Germany, Spain and France, while additional facilities are currently under construction in France and Spain.
